### Director

In 2022, we experienced several sad but also positive events. The most significant of these is undoubtedly the war in Ukraine and the arrival of refugee families with children on Czech territory. Our Žluté Kuře [Yellow Chicken] charity also got involved in helping children, flying in to help and funding what was needed, whether it was Czech language tutoring, psychological help, or school supplies. In addition to this help during this crisis, we have devoted the whole year to the development of interdisciplinary cooperation, a system of care where professionals come together to enable the client to find a comprehensive solution to their problem and situation. Under the pillar of professionalisation, we again improved the image of the nonprofit sector by examining the quality and appreciating the professional work of civil society organisations. We also strengthened staff competencies through online and offline courses and conferences. Our project to modernise apprenticeships was fully underway. NROS has downsized its staff. Thanks to automation and modern technology, we have reduced the quantity of work. We can now focus more on content and programme development.

At the time of publication of this Annual Report, NROS is celebrating a beautiful 30 years and given that next year's mention of this will not be quite as festive, we must at least touch on this important anniversary here. The Foundation was founded in 1993 "out of the need to strengthen and expand the activity of NGOs, to develop their social commitment in the transformation of society

into an open democratic society at the republican and local level". In the 30 years of its existence, it has helped dozens of organisations to emerge into the world, including their development and professionalisation into institutions that today provide key cultural, educational, or social and community services across the country.

Over 2 billion Czech crowns distributed to the sector and 10,000 projects is a number that few other foundations can boast. Very few foundations also function with a minimal operating budget and currently a team of twelve who are incredibly passionate about looking after not only the beneficiaries but also the partners and donors, and I thank them for that. As well as to the members of the Board of Directors and the Supervisory Board who, together with me, have embarked on the necessary changes so that the Foundation can play a long-term and stable role in supporting civil society organisations.

NROS has been an integral part of Czech civil society for 30 years. Many things have been achieved; many things are still ahead. We see our place and role as strongly now as we did 30 years ago, facing different challenges and needs in the Czech civil space. To meet them, we cannot do without donors and supporters. Stay strong with us! We thank you.

# HELP THE CHILDREN

# **Purpose of support:**

We help children across the Czech Republic to live a better and more joyful life despite their disabilities and the environment in which they grow up.



Amount of foundation contributions paid out:

CZK 16,018,301

The Help the Children fundraising project was founded in 1998 by NROS and Czech Television with the aim of providing direct and effective assistance to vulnerable and disadvantaged children throughout the Czech Republic. The well-known mascot of the fundraiser is a yellow chicken with a red and white life ring.

Over the course of its existence, more than 210,000 children have been supported with foundation contributions totalling over CZK 280 million.

# Naděje pro děti úplňku, z.s. [Hope for Children of the Full Moon]

financed by Help the Children

The aim of this organisation's activities is to fill the appropriate support gap for children with autism spectrum disorder, thereby relieving their families from the demands of ongoing care.

As part of homesharing, hosts - trained members of the general public - regularly take in a child with autism. In this way, they provide the child with new relationships and stimulation, natural socialisation, fulfillment of his or her developmental needs, reduction of stress levels and deprivation, reduction of disease progression and thus avoidance of psychiatric hospitalisations. Hosts and families of children with autism set up and plan care so that shared care and host time are comfortable and safe for the child. Furthermore, the project has been expanded for this year to include a psychosocial worker to whom families can refer when needed, and a crisis interventionist with whom the team regularly consults on more severe psychological cases, both with parents and the children themselves. There are also regular therapy groups for siblings of children with autism spectrum disorders.







# Mobilní hospic Ondrášek, o. p. s.

funded by Help the Children

A project called When Children Leave Earlier Than They Should, provides in-home hospice care.



The target group for medical, social and psychological support are children with cancer, neurovegetative, metabolic or other terminal illnesses whose life is threatened by the disease. For example, the project enabled terminally ill Štěpán to spend the last moments of his life with his mum Sylva in the comfort of their home rather than in hospital.

The programme for a group of 19 preschool children from Ukraine focused mainly on games, art making, movement, trips, development of preschool skills and also natural Czech language teaching so that the children could then join school as easily as possible.

Letter from the mother of a terminally ill son to a hospice worker:

### "Dear Broňa,

I was talking to a physio doctor one day and she told me how wonderful it was that I was taking care of Štěpán at home. I replied that it was a matter of course that a mother would take care of her child. And she told me that it's not such a big deal when someone is left disabled or sick, but when they are left to face it all alone. And that's the most important thing. That because of all of you, death isn't such a big deal anymore. Because dying at home in your bed and your pajamas is completely different to dying alone in a hospital among beeping machines. If I were to die in a hospital, I'd want every day to be my last. And at home, I'd look forward to each new day I'd get to see the sunrise and my loved ones. Once upon a time, Štěpán wished for a new cell phone, a better laptop, games. He wanted to be president, a lingerie salesman and wanted to visit a strip bar. But in the end, all he wanted was just one thing. To be back home."

One mum's feedback:

"My daughter loved going to Tosara, it was a nice and welcoming environment. The teachers paid enough attention to her, and she now understands Czech better. Thank you for the opportunity."

The programme improves the quality of vocational education and strengthens the skills of young talents in the Central Bohemian Region.

It is also intended to contribute to the levelling of inequalities in education and to the modernisation of secondary vocational education so that school graduates are more employable on the labour market. Thanks to the project, almost CZK 30 million will be invested in vocational schools over the next five years.

# Secondary Vocational School and Secondary Apprentice Training, Neratovice

financed by the Professional education – a way to a successful future project

A total of 22 contestants from three secondary vocational schools entered the "Hairshow Neratovice 2022" competition. The contestants had to create a formal hairstyle based on the theme "Ball at the Opera" within 90 minutes.

Pupils were given the opportunity to demonstrate what they had learnt and gained experience of working under time pressure and without a teacher behind their backs. They discovered how they can cope when they are on their own with just a model, a mirror, their imagination, and the skills they have gained in their training. The event was positively evaluated by the contestants and the audience.

The support from NROS provided an opportunity for gifted pupils and students with a keen interest in hairdressing to test their skills and knowledge against the other contestants.



# **NONPROFIT** OF THE YEAR **2022 AWARD**

Nonprofit of the Year is an independent prestigious award for nonprofit organisations in the Czech Republic. NROS has been awarding it since 2012 with the help of the "Healthy Organisational Management"© methodology. 120 organisations entered the 10th anniversary year in 2022, of which 55 passed the entry phase and successfully completed the self-assessment form.

The winner of the 10th edition of the Nonprofit of the Year among large organisations was Dobromysl, in the category of medium-sized nonprofits the prize went to Toulcův Dvůr and among small ones the Czech ILCO won. The public award went to Nedoklubko for the second time.








# LADISLAV ČERYCH AWARD FOR DEED OF THE YEAR 2022

# TRAINING FOR COMPANIES AND PARTNERS





- Within the framework of cooperation with Česká spořitelna, a workshop on Crisis Management of Finance and Fundraising and individual consultations for clients from the ranks of nonprofits and clients of the bank took place.
- For ERSTE Group and Vienna University, a workshop on the use of modern technologies and applications in management was held under the auspices of NROS NGO Academy for 14 selected representatives of Czech and Slovak NGOs. The NGO Academy included two full-day courses and a joint meeting with exchange of experience.
- Within the framework of the T-mobile Digital Academy, courses on Modern Technologies in Nonprofit and NROS Digital Office were held for 20 participants from NGOs.
- In cooperation with the ŠKODA AUTO Charitable Fund, NROS organised 3 courses on How to Prepare a Good Project, which were attended by 43 participants from nonprofit organisations cooperating with the ŠKODA AUTO Charitable Fund.

# Association for Faunapark in Frýdek-Místek

financed by VYMY TESCO

The organisation has set itself the goal of creating a pleasant and inspiring place for active recreation, education, social and personal development of the residents and visitors of Frýdek-Místek. The Tree as a House project was aimed at learning about the tree as a home and refuge for forest fauna. The association was founded in 2013 and has been operating on a volunteer basis ever since. Thanks to the volunteers, the park itself was created and, among other things, educational boards were created to educate the general public. Educational programmes about nature and ecology for kindergartens and primary schools are very popular. Various events are also held in the park, be it theatre performances for children or lectures.

# Society for Early Care, České Budějovice branch

funded by Swiss Life charity account

The Association for Early Intervention, České Budějovice branch, is an early care provider for families of children with visual and combined disabilities from birth to 7 years of age in the entire South Bohemia Region and part of the Vysočina Region. The service is provided in the children's home environment, where they feel more confident and make progress more easily. Counsellors visit families regularly to stimulate the child with specialised aids and toys and to give parents information on how best to support the child's development. In practice, a light panel has proved to be an excellent tool for stimulation, providing children with visual impairments with the necessary contrast for perceiving objects and images, and on which the counsellor develops the child's abilities through play.

With the foundation's contribution, the organisation purchased 5 light panels with accessories for visual stimulation, which will serve 130 children.



# **PEPCO** Charity account

The programme focuses on the education and training of pre-school and school-aged pupils. Areas of support focus on tutoring, courses for children, extracurricular educational activities (music, culture, education in relation to nature, etc.) and pre-school education.





# Independent auditor's Report on the Audit of Financial Statements of Nadace rozvoje občanské společnosti

### Recipient

Legal entity: Foundation

Principal nature of business:

- The foundation is established for the purpose of developing and strengthening civil society organizations in the Czech Republic, which were created by the initiative of citizens, and which strive to promote publicly beneficial and democratic values.
- The foundation supports projects and programs of civil organizations focused
  mainly on social and health areas, consumer protection, human rights and
  minorities, environmental care, development of cultural and social life of
  municipalities, cities and regions. At the same time, the foundation supports and
  carries out information and educational activities necessary for the work of these
  civic initiatives. Special attention is paid to projects that focus on European
  cooperation and citizenship education.

### **Opinion**

We have audited the accompanying financial statements of Nadace rozvoje občanské společnosti (hereinafter also the "Organization") prepared in accordance with accounting principles generally accepted in the Czech Republic, which comprise the Balance Sheet as at December 31, 2022, the Profit & Loss Statement for the year ended December 31, 2022 and Notes to the Financial Statements, including a summary of significant accounting policies and other explanatory information. For details of the Organization, see notes to the financial statements.

In our opinion, the financial statements give a true and fair view of the financial position of the Organization as at December 31, 2022, and of its financial performance for the year ended at December 31, 2022 in accordance with accounting principles generally accepted in the Czech Republic.

### **Basis for Opinion**

We conducted our audit in accordance with the Act on Auditors and Auditing Standards of the Chamber of Auditors of the Czech Republic, which are International Standards on Auditing (ISAs), as amended by the related application clauses. Our responsibilities under this law and regulation are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Act on Auditors and the Code of Ethics adopted by the Chamber of Auditors of the Czech Republic and we have fulfilled our other ethical responsibilities in accordance with

these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### **Emphasizing the matter**

We draw your attention to point 2.2. Securities and shares of the annex to the financial statements describing accounting for securities. Our statement is not modified in relation to this matter.

### Other facts

The Organization's financial statements as of 12/31/2021 were verified by another auditor, who in his report dated 5/13/2022 issued an unqualified opinion on these statements.

### Other Information

The other information is in accordance with § 2 letter b) of the Act on Auditors information provided in the Annual report other than the financial statements and our auditor's report. The Administrative Board of the Organization is responsible for other information.

Our opinion on the financial statements does not cover the other information. In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements, or our knowledge obtained in the audit or otherwise appears to be materially misstated. In addition, we assess whether the other information has been prepared, in all material respects, in accordance with applicable law or regulation, in particular, whether the other information complies with law or regulation in terms of formal requirements and procedure for preparing the other information in the context of materiality, i.e. whether any non-compliance with these requirements could influence judgments made on the basis of the other information.

Under those procedures, we received other information not found anything like this.

### Responsibilities of the Administrative Board for the Financial Statements

The Administrative Board is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the Czech Republic and for such internal control as the Administrative Board determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Administrative Board is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Administrative Board either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. However, future events or conditions may cause the Organization to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
